Functions of the Judiciary of Hong Kong



The Judiciary is responsible for the administration of justice and conducting hearings for criminal and civil litigation cases in Hong Kong. They are independent of the executive authorities and the legislature.

Appeal mechanism is an important aspect of the rule of law. There are appeal mechanisms for both civil and criminal cases. In general, each case has at least two opportunities for appeal.

How to safeguard independent judicial power?

How do we ensure that the judicial power of the judges in Hong Kong can be exercised free from any interference?



Independent judicial power is protected by the Basic Law.

When assuming office, judges must take the judicial oath to uphold the Basic Law, and safeguard the law and administer justice without fear or favour, self-interest or deceit.
